- 1. Discussion of American Rescue Plan (ARP) funds coming to Baltimore City: The board discussed a process by which YRP committees would meet and recommend to the board their ideas for the use of these funds in the York Road Community and find organizations that have capacity to implement the projects. The committee work needs to include understanding what other organizations and city agencies are applying for. Each City Councilperson has the ability to "favorite" 10 projects, as per the City's process. The minimum amount for each project is \$250,000. At the September 27 agenda-setting meeting, this group will discuss the recommendations and next steps.
